1.0 Opening				
The DLMSD in Kade Forest District was held on 20 <sup>th</sup> October 2009. The CFW, William				
Koranteng called the meeting to order at 10: 15 am. Mr. Koranteng welcomed the EU				
Chainsaw team and also facilitated the meeting.

The NF/CFA presented the research findings covering the following areas:

ii. The policy and legal aspects of CSM				
iii. Why the law has been ineffective				
iv. Drivers of CSM				
v. CSM and the domestic market				
vi. The impacts of CSM (social, economic, environmental)				
vii. Potential loss to the state				
viii. Beneficiaries of chainsaw revenue				
ix. Recovery efficiencies of the various technologies for sawing lumber				
x. The three options as emerged from the Technical Committee meeting				
She added that, the TIDD conducted similar research and the findings are almost the same as				
that of the chainsaw project. This she stressed authenticates the findings of FORIG research.				

This also implies the information is credible to rely on for finding lasting solution to the CSM in Ghana.

# 4.1 Contributions

The following were some contributions from participants:

- I. The ban on CSM has to be lifted to allow chainsaw operators to have permits to operate since the poor in society can only afford chainsaw lumber. In such a situation government will have its share of revenue from chainsaw activities.
- II. The ban should be lifted with policies and conditions for regulation.
- III. There is the need for massive aforestation which should involve people along the chainsaw chain and if possible all logging in forest reserves should be halted and replaced with the importation of wood
- IV. There is the need to halt rural-urban drift in that more jobs should be created in rural areas to avoid overpopulation in the cities. For example the presence of state farms or factories will siphon a lot of the carries and chainsaw operators which will then cause a break in the chain.
- V. There have been lots of discussions on CSM but the plea of chainsaw operators is to lift the ban and to look at how best to protect the forest. The fear now is that even with the ban in place chainsaw operation is ongoing in some forest reserves. The question to consider now is what chainsaw operators can do to help protect the forest. CSM can be organized to help in forest management.
- VI. The problem is how permits when granted can be used. It is important to train chainsaw operators with the resources used to chase them on best tree logging practices and told what they can log.

# 5.0 Outcome of First MSD Meeting

Copies of minutes of the first MSD meeting were distributed to stakeholders. The NF/CFA and the CFW briefed the meeting of the key outcomes of the meeting in Accra.

## 6.0 Group Discussions

Participants of the meeting were put into three groups to study the three policy options and raise issues of concern under each option. Copies of the issues raised under the options will be given to the national representative for further study and presented during the second MSD.

## 7.0 Integration of DLMSD into DFF and Nomination of Steering Committee Members

The NF/CFA informed the meeting that since the National level MSD has been integrated into the NFF, it will be appropriate to do same for the DLMSD and the existing DFF where forestry issues in general will be discussed (chainsaw issues inclusive). The meeting therefore agreed that the DLMSD should be integrated into the kweabibriem DFF. The meeting nominated the following persons in addition to the CFW to form the DLMSD management team:
